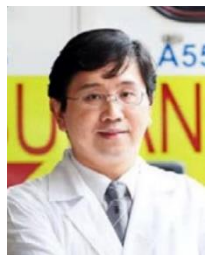




## OE Hong Kong Chapter Committee Members

**The Honorable Raymond Sears (R 1946-51) Hon Chairman**

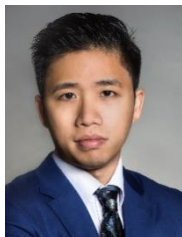


A former High Court Judge in Hong Kong for 14 years. One of five 'Sears' who have been through Epsom College.
