GCSE Guidance for Students and Parents

Now you have received your examination results, the following services are available to you. It is vitally important that you seek advice from College staff (HoDs, HoYs, Mrs Brown) on the actions you need to take as the choices can be complicated. Members of staff will be available in the Mermaid on Results Day.

The most relevant services available to you are:

Priority Copy of Script to support a Review of Marking (ATS)

Deadline: 4th September 2025

If you are thinking of requesting a review of marking, then you should first consider asking to see a copy of your examination paper. Scripts are returned to the College in time to allow you to make an informed decision on whether to pursue a **non-priority** review of marking. Priority copies **should** arrive in College before the deadline for deciding on a review of marking, but must be ordered on Results Day.

Review of Marking

Deadline: 25th September 2025

If you believe that a paper has been marked incorrectly, you can ask the exam board to review their marking. **Reviewers will not remark the script;** they will review the original marking to ensure the agreed mark scheme was applied accurately and correct any errors. **You must be aware that marks can go up and down**, which could affect your grade negatively. You must speak to College staff before requesting this service.

Standard Copy of Script (ATS)

Deadline: 25th September 2025

You can request a copy of your examination paper to support teaching and learning. It can be used to help you prepare for a resit. Papers should arrive late September/early November.

Priority Review of Marking (Pearson only)

Deadline: 9am 28th August 2025

Priority reviews are typically reserved for A Level students requiring a quick response for University places. Only available on Pearson exam papers.

Reviewers will not remark the script; they will review the original marking to ensure the agreed mark scheme was applied accurately and correct any errors. **You must be aware that marks can go up and down**, which could affect your grade negatively. **You must speak to College staff before requesting this service.**
